### **First Monday Seminars**

On the first Monday of every month from early Fall through May, WCBA hosts educational seminars for its members. All seminars are held via Zoom and some also have an in-person component, being held in the Worcester County Courthouse, during the Court's lunch hour from 1:00 – 2:00.
